TEMA I.- Genres: newspaper article, press release, fact files. Awareness raising of the genre system. Rhetorical functions: reporting and narrating; describing a problem; suggesting a solution; giving reasons and explanations; giving instructions. Lexico-grammatical features: the verbal phrase: past tense and present perfect tense; modals expressing: ability, possibility, obligation, prohibition, advisability, recommendation; degrees of certainty and others. Noun phrases.

TEMA II.- Genres: biographies, history of scientific breakthroughs. Rhetorical functions: describing a sequence of events, narrating. Lexico-grammatical elements: the verbal phrase: past tenses; complex noun phrases; sequence and time markers.

TEMA III.- Genre: research article. Part genre: Materials & Methods section. Rhetorical functions: describing method/ equipment/ process; using visual and verbal semiotics in scientific discourse. Lexico- grammatical features: cohesion enacted by noun phrases. Passivization with /without agent.

TEMA IV.- Genre: oral presentations. Rhetorical functions in academic speaking: introducing topic and organization of talk, following and referring back to the plan, reformulating, describing a sequence of events, narrating and reporting, encouraging audience participation, dealing with questions. Writing and designing a presentation complemented by slides.

TEMA V.- Genres: report. Rhetorical functions: using the problem-solution macrostructure; comparing and contrasting; describing cause and effect; generalizing; hypothesizing and speculating; hedging. Lexico- grammatical features: conditionals, expressing attitude, modals.
